The Registrar(Computerization)-cum-Director (IT), as per the letter cited above, informed that the Hon'ble Supreme Court of India had launched the e-SCR Portal, a web portal which provides free access to the reportable Judgments of the Supreme Court and the High Courts to lawyers, law students and the common public in English as well as regional languages. The most important feature of this portal is a free text search engine, which finds out Judgments based on a given keyword or combination of keywords.

The search facility in e-SCR portal provides for free text search, search within search, case type and case year search, judge search, year and volume search and bench strength search options. Combination of any of the search criteria can be used to filter results. The embedded filtering

feature allows further filtering on available results, thus adding value to the search. The e-SCR Free Judgment Search Portal is a valuable resource for accessing judgments and orders from various Indian High Courts. The URL for accessing the e-SCR portal is https://judgments.ecourts.gov.in/.
